MINUTES OF THE JULY 14, 2025 – REGULAR CITY COUNCIL MEETING

City Council of the City of Brush, Colorado met in regular session on July 14, 2025. Mayor Dana Sherman called the meeting to order at approximately 6:00 pm. The meeting was held in the Council Chambers of Brush City Hall, 600 Edison, Brush Colorado.

AGENDA

Motion to approve the agenda was offered by Councilor Klinkhammer, seconded by Councilor Tyree, and approved by unanimous roll call vote following no further discussion. The motion passed and the agenda for the regular Council meeting of July 14, 2025 was approved as submitted.

MINUTES

Motion to approve the minutes for the regular meeting of June 23, 2025 was offered by Councilor Spradlin, seconded by Councilor Klinkhammer, and approved by unanimous roll call vote following no further discussion. Minutes were approved as submitted.

a) Citizen Comments
