

ADVERTISEMENT FOR BIDS

Sealed Bids for construction of the **Regional Reuse System – Phase 1A** project, addressed to **Holley Navarre Water System, 8574 Turkey Bluff Road, Navarre FL 32566**, will be received at the office of the Holley Navarre Water System, Inc, (Owner), until 10:00 a.m., local time, on the 20th day of June, 2023. Any Bids received after the specified time will not be considered.

Bids will then be publicly opened and read.

The Project contemplated will provide Holley Navarre Water System with seven new rapid infiltration basins (RIBs) and new reuse water force main within the project limits. This facility also will be capable of expansion in the future and provisions will be made for later connection to the facility piping network to be made during a separate contract. The major items of the Work to be performed as part of this project includes:

- Preparation and submission of submittals for review and approval.
- Surveying and existing utility mapping.
- Obtaining construction stormwater permit from the Florida Department of Environmental Protection, implementation of a construction best management practices plan (CBMPP) for erosion and sediment control, monitoring and maintenance of the erosion control measures.
- Installation of a reclaimed force main, outfall structures, control valves, fittings, and manholes.
- Installation of air release / vacuum release valves and manholes.
- Construction of rapid infiltration basins (RIBs).
- Restoration and construction of site access include paving, grassing and stabilization.
- System startup and performance testing.
- Preparation of record drawings.

The Work will be completed in all respects within 365 calendar days from the date when the Contract Times commence to run.

Questions regarding the Contract Documents must be submitted electronically to JACOBS through Seth Tatman no later than 4:00 p.m. CDT, June 8th, 2023 in order for responses to be provided via addendum.

Each Bid must be submitted on the prescribed Bid Form and accompanied by Bid security as prescribed in the Instructions to Bidders.

REGIONAL REUSE SYSTEM PHASE 1A

The Successful Bidder will be required to furnish the additional bond(s) and insurance prescribed in the Bidding Documents.

In order to perform public work, Bidders shall hold licenses as required by Florida State Statutes, and federal and local Laws and Regulations.

Bidders will be required to comply with Florida Trench Safety Act, FS 33-553.60 through 33-553.64, relating to the state's trench safety standards.

In accordance with the provisions of Florida Statute 19-287.133, Bidder who has been placed on the convicted vendor list may not submit a Bid on a Contract with a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with public entity, and may not transact business with public entity in excess of the threshold amount provided in Section 287.017 for category two for a period of 36 months from the date of being placed on the convicted vendor list.

In accordance with the provisions of Florida Statute 19-287.134, Bidder who has been placed on the discriminatory vendor list may not submit a Bid on a Contract with a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with public entity, and may not transact business with public entity for a period of 36 months from the date of being placed on the discriminatory vendor list.
