PROGRAM/TECHNICAL REPORT

Activities Performed from July 1, 2021 to September 30, 2021:

Background: TRLIA at the request of Yuba County, has proposed a program to reduce the flood risk to the Community of Hallwood by strengthening the Yuba River North Training Wall (NTW) and tying it into high ground at the upstream of the project area. TRLIA's effort builds upon an alternatives evaluation of the flood risk to the Community of Hallwood from the Yuba River NTW that was previously funded by Yuba Water Agency (YWA). The alternatives evaluation provided a project recommendation that will serve as the basis for further design and subsequent construction. In addition, TRLIA's work will also build upon an interim repair that strengthened a critical reach of the NTW that Yuba County worked to complete with Teichert in 2019.

The Yuba River NTW project has two phases. Phase 1 will reshape and strengthen the 2.25 mile NTW cobble embankment to a more stable geometry using surplus material contained within the NTW. Phase 1 is being constructed by Teichert Materials and is scheduled to be complete in late fall/winter 2021. Phase 2 will construct the upstream high ground tie in to form a contiguous line of protection.

In April 2021 TRLIA received \$1,100,000 in grant funding from YWA to complete project planning, select a project alignment, develop a 65% design, complete permitting, and support CEQA & NEPA compliance for the NTW Phase 2 project area. Completing the NTW Phase 2 tasks as indicated will increase the likelihood and competitiveness for grant funding through the State of California and FEMA under various grant programs.

Cost Information

Costs accrued for this reporting period (Q3 2021) are: \$66,053.51. Amount to be paid is \$66,053.51. Attachment 1 provides a list of all costs accrued and associated invoices. Costs will be updated in each

progress report. Please note, TRLIA and the project team performed a small amount of activities for the NTW Phase 2 project in June 2021; these activities are included in the descriptions below as well as the attached invoices.

TRLIA accomplished the items listed below during Q3 2021:

Task 1: Contract Subconsultants and Assemble Team: In July 2021, the TRLIA Board approved scopes of work and executed contracts with the following firms to support the NTW Phase 2 Project:

- Wood Rodgers and ENGEO: Civil and Geotechnical Design (\$513,428)
- GEI Consultants: Environmental Compliance (\$261,816)
- MBK Engineers: Program Management and H&H Analysis (\$250,000)

Task 2: Preliminary Engineering and Design: TRLIA and the consultant team held 3 project team meetings and several smaller coordination calls focusing on geotechnical data collection, alternative alignment analysis, right of entry, and basis of design. More specifically the consultant team completed the following tasks:

- Develop Design Water Surface Elevation (DWSE): For consistency with the NTW Phase 1 Project, MBK Engineers in coordination with the project team, determined that a DWSE (200yr+2ft) would be used in the project design. Additionally, the top of structure for the NTW Phase 2 project will be designed to include 3 feet of freeboard above the DWSE. The DWSE will be documented in a technical memorandum prepared by MBK Engineers.
- Right of Entry (ROE): TRLIA executed ROE agreements with Western Aggregates and Hallwood-Cordua Irrigation District to access the project area. The ROE agreements will allow the project team to complete eight (8) geotechnical explorations which will include 2 sonic borings, and up to 6 test pits. The explorations will gather subsurface stratigraphy information and inform geotechnical analyses and project design efforts.
- Geotechnical Explorations: ENGEO coordinated with a subsurface drilling contractor to perform 2 sonic explorations (completed late September) and contracted a backhoe operator to perform 6 test pits (schedule to be completed October 2021).
- Alternative Analysis and Preliminary Design: The Project Team began an alternatives analysis
 effort to evaluate constraints of four (4) potential project alignments. An existing side channel
 runs throughout the project area and presents challenges with project alignments that may cross
 this feature. Wood Rodgers has performed preliminary earthwork modeling to determine cut and
 fill quantities for the project alignments. The earthwork models will be used to support
 construction cost estimates.

Task 3: Environmental Surveys and Compliance (CEQA): GEI performed biological field resources surveys and completed associated evaluations to identify project constraints. These efforts were specific to cultural, biological, and habitat surveys and will support development of a project description and draft IS-MND.

Task 4: Evaluate Current and Future Grant Funding Opportunities: TRLIA and the project team worked collaboratively to identify and assess funding opportunities for the NTW Phase 2 Project.

In September 2021, California Department of Water Resources (CA DWR) finalized a grant solicitation under the Proposition 68 – Floodplain Management, Protection, and Risk Awareness Grant Program (FMPRA). The grant solicitation provides a total of \$50M in planning (\$5M) and implementation funding (\$45M). The first phase, a concept proposal, of the application is due in late October 2021. The full application submittal will follow upon CA DWR approval of the concept proposal, and is due early February 2021. TRLIA intends to prepare an application for implementation funding for the NTW Phase 2 Project.

The project team is in the process of contracting Grant Management Associates (GMA) to complete a key considerations analysis of the grant application. This effort will seek to increase the overall competitiveness of the NTW Phase 2 project application. Additionally, if CA DWR approves the concept proposal, GMA will prepare the benefit cost analysis and supporting narrative for the full application.

Projected Expenditures in Q4 October 1, 2021 – December 31, 2021

During Q4 2021, the projected expenditures will be approximately \$100,000.

Task 1 – Contract Subconsultants and Assemble Team: MBK intends to execute a sub-consultant agreement with GMA to support grant application preparation and economic analyses.

Task 2 – Preliminary Engineering and Design: During Q4 2021 it is anticipated that TRLIA and the Project Team will select a preferred project alignment. Wood Rodgers – ENGEO will complete preliminary design geotechnical analyses (through-seepage, underseepage and land side slope stability), and prepare a construction cost estimate for the preferred project alignment.

Task 3 - Environmental Surveys and Compliance (CEQA): GEI will prepare a draft project description for the preferred project alignment and begin development of a draft CEQA document (IS-MND).

Task 4 – Evaluate Current and Future Grant Funding Opportunities: Upon CA DWR approval of the Prop 68 FMPRA – Concept Proposal, the project team will begin preparation of the full grant submittal which will include a benefit cost analysis.
