

Visiting Contract

Wabasha County Jail

The personal data requested of you is for the purpose of identifying you and determining eligibility for visitation with an inmate. The information will be used by jail staff. You do not need to provide the information; however, if you refuse to provide the information requested, you will be denied a visitation with the inmate.

By signing this contract, I acknowledge reading and understanding the visiting rules and regulations listed below. I understand that any violation of the rules may result in the termination of my present or future visits.

1. You must obey the directives of Sheriff's Office staff.
2. All visitors must be on the inmates approved visiting list.
3. All personal property must be left in your personal vehicle or secured in the lockers located in the main lobby. **THIS INCLUDES CELL PHONES.** You and your personal property may be subject to search.
4. You must have a valid state issued ID and be over the age of 18 to visit. Children who are under the age of 18 and are the child/children of an inmate may visit, if accompanied by an adult who is on the approved Visitor's List.
5. Children, other than the child/children of the inmate, may not accompany you into the visiting room and may not be left unattended in the lobby.
6. Visitors entering with contraband can and will be prosecuted to the full extent of the law.
7. You may not visit under the influence of drugs or alcohol.
8. Visitors wearing inappropriate clothing will be denied a visit. Appropriateness of clothing will be determined by staff.
9. Loud, inappropriate, provocative or disruptive behavior in the visiting room is not permitted.
10. For the safety and security of the facility, all visits are monitored by visual and audio equipment.
11. All approved visitors may visit once per day for up to 40 minutes per inmate. (Visit time may be limited to 20 minutes per visit if there are visitors waiting).
12. No food or drink is allowed in the lobby or the visiting room.
13. The lobby is a business environment and you must be quiet except for conducting business with staff on duty.
14. Visitors must arrive 30 minutes before the end of scheduled visiting times to be allowed a visit. (If you arrive 30 minutes before the end of scheduled visiting hours, you will only receive a 20 minute visit).
15. Destruction of visitation telephone equipment or any other county property will result in arrest and criminal prosecution.
16. Visitors may visit only one inmate during their scheduled visit time.
17. Once a visitor leaves the visiting room, the visit is terminated. You are not to re-enter the visiting room.
18. If a visit is terminated for violation of any visiting rules, you may be removed from the visitor's approved list.
19. If you have been an inmate in the Wabasha County Jail during the past three (3) months, you are not allowed to visit.
