Rich, and Aubrey Cooper were not in attendance. Also in attendance was Deputy Town Clerk Ravi Boze-Adams.

The first item on the agenda was to appoint the Steering Committee's Chair and Vice-Chair, set a regular meeting schedule, and agree on the agenda layout. Hurd presented the options available. After a brief discussion, it was decided to meet the 2nd Friday of each month at 10am. Mayor Flowers was selected as Chair and Member Goldman was selected as Vice-Chair.
